ADOPT AN OLIVE TREE PROJECT

ADOPTION CONTRACT

The present adoption contract is stipulated, specified in the following points

Art. 1

The adoption will have a duration of one year, from the moment of the completion of the present contract. Any renewal will not take place tacitly, but must be renewed by resubmitting a new contract form and a new payment.

Art. 2

Multiple olive trees can be adopted, filling in several forms and sending the fee for each olive tree.

Art.3

On the adopted olive tree will be placed a plate with the name and place of residence of the adopter. Those who wish can have a nickname inserted instead of the name.
The adopter will receive, by email, a certificate of adoption showing his data and the geographical location (through GPS coordinates) of the olive tree and a photo.

The adopter will receive twelve 500ml bottles of extra virgin olive oil, in particular 4 bottles of Madremignola extra virgin olive oil, 4 bottles of Mignola extra virgin olive oil, 4 bottles of Blend Frantoio LeccinoMoraiolo extra virgin olive oil.

The adopter will be entitled to a discount on the visit with tasting, by reservation, at our company. The adopter may, if he does not come directly to the company, assign this right to other persons who will indicate to us when booking.

Upon request we will send the program and the costs.

With this contract no property rights are ceded on the plants and land where they are located.

Art.4

The adopter will be informed periodically, by e-mail, about the work and the progress of the season.

Art.5

The quota envisaged for adoption is set at € 150.00 (Euro one hundred and fifty / 00).

To this must be added the shipping costs of the oil. For Italy, the cost is set at € 15.00 for any location.

For the foreigner, the adopter, before signing the contract, will have to send us the address to which the oil should be sent, in order to be able to supply the shipment cost. If the adopter has an account with a courier, can send us his code and we will ship with that courier directly charging the charges on his account.

Art.6

The payment of the fee can be made by bank transfer or Pay Pal.

Upon receipt of this form duly compiled and signed, we will send you the coordinates to make the payment. The contract will be valid and active at the receipt of payment.

Art.7

If the contract is signed by April 30 of each year, will be sent the extra virgin olive oil of the last harvest. After April 30th the oil of the next harvest will be sent.

Art.8

The undersigned _____ authorize the Azienda Agricola Poggio Cappiano di Fabrizio Mazzantini to process personal data in accordance with art. 7 Italian Law 196/2003 "Protection of Personal Data", with reference to the sending of information. At any time I have access to my data, I can request the modification, deletion or integration, or oppose their use.
